8 Things You Need to Know About Express Lanes

If you're sitting in traffic on the freeway watching cars zip by in the express lane, you may decide it's worth the toll to hop into the lane—even if just on occasion. Before you do, here's what you need to know:

1. You must have a transponder in your vehicle and valid account to use express lanes. [The cost to open an account](#) and fees varies depending on how often you plan to use the lanes.

When you sign up, your account allows you to use any express lane in Southern California.

2. You may have heard that 3+ person carpools can use express lanes for free. What many people don't know is that the [405 Express Lanes](#) also allow 2+ carpools to ride free during non-peak hours. These include weekdays (10 a.m. – 2 p.m. and 7 p.m. to 6 a.m.) and weekends (12 a.m. to 1 p.m. and 7 – 12 p.m.).

On the [91 Express Lanes](#), 3+ person carpools currently ride free except eastbound weekdays from 4 to 6 p.m., when they get a 50% discount.

3. To ride free or at a discount, you need an active account and a FasTrak switchable transponder, set to the number of people in the vehicle (which must meet minimum occupancy requirements).

Ride Free on Transit Equity Day

Transit Equity Day is Feb. 4. In honor of Rosa Parks' birthday, it's a day that promotes making transit affordable and accessible to people in all communities.



Rides will be free on OC Bus, Metro Bus and Rail, Riverside Transit Agency (RTA), and all San Bernardino County and Ventura County buses.

Fares are also free all day on Metrolink trains throughout Southern California. Simply arrive at the station and board the train (no ticket required). Note: Pacific Surfliner (including codeshare Rail 2 Rail) will not be offering free rides.

Don't Forget to Renew Your Club Rideshare Membership for 2026

The OC Rideshare Office sent out emails last month to all current Club Rideshare members to renew their participation, which is required annually.

When you renew, you'll get a \$15 bonus in your paycheck—plus you'll continue to qualify for monthly \$25 prize drawings.

- 4.** The Riverside County section of the 91 Express Lanes now uses an Occupancy Detection System that digitally counts the number of people in a vehicle. Even if your transponder is set to three occupants, if you have fewer than that, you will be fined.
- 5.** Violation rates include the posted toll as well as a penalty fee. On the 405 and 91 Express Lanes, the penalty is \$25. (Metro ExpressLanes on the 10 and 110 freeways recently dropped the penalty to an \$8 processing fee.)



- 8.** Sitting in traffic isn't the only alternative to express lanes! Metrolink's 91/Perris Valley Line trains runs parallel to portions of the 91 Freeway. It could be a faster way to commute without having to get on the freeway at all.

You may also have access to time-saving carpools lane along your route to work. Only two occupants are required to use them, and they're always free.

- 6.** Clean air vehicles no longer qualify for toll discounts.
- 7.** Violation notices are mailed to the address registered to your vehicle. If you receive a text message or email regarding unpaid tolls or violations, it is likely a phishing scheme. You should not respond to the message or click any links in it.

To be in Club Rideshare, you must have carpooled, vanpooled, rode bus/rail, biked or walked to work 20 or more times over the past 90 days. Driving an electric vehicle and the days you telework also count toward your rideshare totals.

Complete a renewal application directly online or download a PDF that you can print out, fill in and submit to the Rideshare Office.
