Renew Your Club Rideshare Membership, Get \$15

1. Good news for motorists on the I-5...

Construction that began in 2019 to make improvements on the I-5 Freeway is projected to be completed early this year.

New \$2,000 E-Bike Incentive Available

The California Air Resources Board is providing incentives of up to \$2,000 toward the purchase of a new electric bicycle (e-bike).



Some of the funds are earmarked for low-income/disadvantaged applicants as well as those in a defined income range.

To claim a voucher, apply online and provide residency and income verification documents. Prior approval is required before purchasing an e-bike. It is open to residents aged 18 or older.



cooperation with Caltrans has been **improving I-5 between SR-73 and El Toro Road**. The project covers 6.5 miles of I-5 through Mission Viejo, Laguna Niguel, Laguna Hills, and Lake Forest.

When complete, it will include a new general-purpose lane in each direction from Avery Parkway to Alicia Parkway.

Improvements to the carpool lanes are also part of the project. This includes an extension of the second carpool lane from Alicia Parkway to El Toro Road.

Carpool lanes are also being converted to continuous access, making it safer and easier for motorists to enter and exit the lanes at any time.

2. OC Streetcar is slated to open late summer.

OC Streetcar is Orange County's first modern streetcar. It will serve Santa Ana's historic downtown, which includes courthouses, government offices, colleges, restaurants and more.

The streetcar will operate along a 4.15-mile route, connecting with the Santa Ana Regional Transportation Center (SARTC) and a new transit hub at Harbor Boulevard and Westminster Avenue in Garden Grove.

There are 16 stops along the route with 10 stops in each direction.

During construction, get discounts and deals at participating merchants as part of OCTA's **Eat, Shop, Play** program.



3. Transportation fringe benefit gets a raise.

You can receive transit and vanpool benefits tax-free up to \$325 a month in 2025.

That's a **\$10 monthly increase over the 2024 transportation fringe benefit**.

The Rideshare Office allows employees to purchase transit fares using payroll deduction.

(no ticket required) to ride Metrolink all day, anywhere it goes.

Rides are also free for the day on Metro Bus and Rail and Bike Share, OC Bus and all San Bernardino County and Ventura County buses.



Costa Mesa Introduces Free Shuttle

Costa Mesa recently launched **Let's Go Costa Mesa**, an on-demand rideshare service. ADA-accessible 10-passenger vans transport riders within an area around the East 17th Street shopping district.

Vans run weekdays 8 a.m. to 6 p.m. and 10 a.m. to 8 p.m. on Saturday and Sunday. Download the Ride Circuit app through Apple Store or Google Play, or call the hotline at 949.828.2065, to schedule a pickup.



Vanpooling May Be More Affordable Than You Think

A vanpool is a sort of “super carpool”—a group of five or more people who commute together in a leased van, splitting expenses. It’s a great way to get to work without the stress of daily driving.

Did you know it can also be a bargain? That’s because in a vanpool, you’re not footing the entire bill for gas—plus you’re saving on wear and tear on your car.

If you’ve thought about vanpooling but worry it might be out of your budget, here are some deals that bring costs down:

1. If you start a new vanpool, you could be eligible for a **\$300 start-up bonus** through the County.
2. Orange County Transportation Authority (OCTA) offers **subsidies of up to \$800 a month toward vanpool lease costs**. Qualifying vanpools earn \$600 every month. Additional monthly subsidies of \$100 are available if you operate at 85% or higher capacity with an 8-passenger van and \$100 if you lease a zero-emissions van.
3. Sign up to pay for vanpool fares though the Rideshare Office using pre-tax dollars to **save money by reducing your overall taxable income**.
4. Vanpooling will allow you to join Club Rideshare, **earning a \$40 bonus** (or a \$15 annual renewal bonus). You’ll also be entered into monthly drawings for \$25.

Better Connections on OC Bus

OC Bus made several adjustments to its schedule last month to improve service for riders. One of the major changes: Buses at the Laguna Hills Transportation Center now wait five minutes between arriving and departing. If you’re transferring from other routes, this gives you more opportunity to make your bus connection—so there’s less waiting overall.

Ride Arrow for Just \$1

Riders can board Metrolink’s Arrow service for only \$1 through March. Arrow trains serve five stations and cover a nine-mile route between the cities of San Bernardino and Redlands.



The discounted fare promotion includes free transfers to Omnitrans and Beaumont Transit.

5. If you don't mind driving, see if you can volunteer to be the driver in exchange for free or reduced fares. (Many vanpools use this arrangement, while others split driving duties among riders.)



6. Vanpools that travel the 91 or 405 Express Lanes can ride in them free or at a discount—saving money on tolls while still shaving time off the commute.

Ready to get started?

To see if there's a seat open on a vanpool serving your commute, log in at ridematch.info.

The 405 Express Lanes Celebrate One Year of Keeping Orange County Moving

Some fun facts about these lanes:

- The 405 Express Lanes cover 14 miles of I-405 between the SR-73 freeway in Costa Mesa and I-605 near the L.A. County line—one of the busiest stretches of freeway in the nation.
- They carry about twice as much carpool traffic as nearby freeways due to a policy of allowing 3+ person carpools to travel for free.
- Roughly one in four of the vehicles using the toll lanes are carpools.
- Drivers traveling northbound in the 405 Express Lanes can save 20 minutes more during weekday evening peak hours than they did in the carpool lanes that existed prior to the project's construction in 2018.
- Traveling the full 14 miles in the 405 Express Lanes takes about 15 minutes at all hours, allowing users to count on a more reliable commute.

Need to Get Home from Work Due to Emergency or Illness?


On a day that you carpooled, vanpooled, rode the bus or Metrolink, biked or walked to work, you can be reimbursed for the cost of a ride home in case of emergency or illness (up to twice in a fiscal year, July 1 - June 30).

The [County's Guaranteed Ride Home program](#) allows you to rideshare to work without worrying about being unable to get home if you need to.



A Tax Season Reminder:

If you vanpool or ride the bus/Metrolink to work and pay fares through payroll deduction, this is a reminder that for the 2025 tax season, there's a slight bump in your allowable deduction. The 2024 maximum of \$315 for 2025 is \$325 per month.



If you aren't currently paying fares using pre-tax dollars via payroll deduction, you could be missing out on tax savings. Contact the Rideshare Office for more information, or sign up using the [Voluntary Payroll Deduction Authorization Form](#).

Throughout Southern California

Bikes are allowed on all trains, and Metrolink also features special **Bike Cars** designed to accommodate more bikes.



5 Ways to Save Time if You Ride Transit

1. **Use the Transit App.** Most Southern California transit providers use the **Transit app** to show actual bus arrival times based on real-time data. You can spend less time waiting and wondering when your bus will arrive.
2. **Check the Metrolink Real Time Train Tracker.** An official time-tracking app for Metrolink maybe in the works—in the meantime, you can use the real-time train tracker online at metrolinktrains.com. Just enter your station to see when your train will arrive. It also lists any advisories that could impact your ride.
3. **Buy fares through the rideshare office.** Instead of dealing with ticket machines, you can simply order your bus pass or Metrolink tickets through the Rideshare Office. Not only will you save time, but you'll also qualify for a lower fare—plus when you use payroll deduction, you'll lower your overall taxable income as well.
4. **Look for express bus routes.** OC Bus has four **Rapid Bus lines** that run along the same route as local buses but make fewer

Special guest speakers will get the crowd pumped about Bike Month. Then join other cyclists on a 3-mile ride to OCTA Headquarters in Orange.



Getting Ready to Bike to Work


If you're new to bike commuting, you might want to prepare before heading out on the road.

Gear up. If your bike has been in the garage for a while, take it to your local bike shop for a tune-up.

Select a route. The route you bike isn't always the same as what you'd drive. Resources like the **Map My Ride** app can suggest a route with bike paths and fewer hills. OCTA recently updated its **bikeways map**.



Consider a "bike buddy." Is there anyone at work who lives nearby that might want to ride to work with you? Knowing that someone is counting on you to ride with them can strengthen your resolve. Two bikes on the road are also more visible—and therefore safer—than one.



Speaking of safety. Buy a Snell/ANSI-approved helmet – then wear it. Check your bike for reflectors (required in California for riding in the darkness) and other safety features. Wear brightly colored clothing, especially if you bicycle at dawn or dusk.

Riding an e-bike? OCTA has plenty of useful information, including rules of the road, safety tips and upcoming e-bike classes, at octa.net.

stops, so take less time. If you live in Riverside, the **CommuterLink Express** with routes into Orange County may be a time-saving option for you.

5. Get home fast in an emergency.

Don't worry about riding the bus home if you need to get home due to illness or emergency on a day you took transit to the office. You can instead take a train, Uber/Lyft or taxi if that will get you there faster. The **County's guaranteed ride home program** will reimburse you for the cost (up to two times per fiscal year).



Ridematch.info Gets a New Look and Interface

The next time you log into your ridematch.info account, you may notice it has a new look.

The regional rideshare database recently underwent an update, giving it a more user-friendly design. Whether you've moved, changed your schedule, or simply want to try a new way to get to work, ridematch.info makes it easy to find the help you need.

It allows you to:

- Generate a list of potential carpool or bicycling partners—people who live and work near you and work a similar schedule.
- Find available seats on a vanpool.
- Get instant transit routing, including Metrolink and commuter express bus options.
- Locate EV charging station locations.
- Calculate how much you're spending on the commute—and how much you are saving by ridesharing or teleworking.

You can also learn about special incentives and promotions available to commuters.

A Few Fiscal Year, New Rides Home

County of Orange and Superior Court employees can be reimbursed for a ride if they need to get home due to an emergency on a day they got to work by ridesharing—up to two rides per fiscal year. Emergency ride options include taxi, Uber/Lyft and transit.

San Clemente Rail Stabilization Update

Passenger rail service through San Clemente is expected to reopen early this month.

It has been suspended since April 28 to allow crews to reinforce sections of track at immediate risk from landslides and coastal erosion.

The section under repair is the only coastal rail link between San Diego and Orange counties. Over the past four years, San Clemente's eroding bluffs have repeatedly forced the closure of the rail line that had otherwise operated largely uninterrupted for more than 125 years.

School is out but youth aged 6 to 18 can still ride free on OC Bus with the [Youth Ride Free Pass](#). The passes are available from your child's participating Orange County school (parental signature is required). Or [click here](#) to request one online.

Metrolink's Student Adventure Pass—which allows riders 18 and younger to board free—will continue through June 30. After that, students using the pass will receive a 50% discount on fares.



When Will My Train Get Here?



Metrolink launched a new alerts tool last month that makes it easier for riders to track real-time train arrivals and service interruptions. You'll be able to better time when you need to get to the station or make alternate travel plans if your usual train isn't available.

5 Ways Hybrid Workers Can Save on the Days They Commute

Just because you telework some days doesn't mean you're doomed to the expense and hassle of driving alone on the days you commute. Here are five ways to save time and money:

- 1. Help an existing two-person carpool qualify to use Express Lanes.** Carpools with three or more passengers ride free or at a discount on the 91 and 405 Express Lanes (when using a transponder). The Rideshare Office may be able to match you with a current two-person carpool that would appreciate the chance to ride free in these time-saving lanes if they added another person, even if not every day.
- 2. Try transit.** Give riding the bus or train a try and you can be reimbursed for a portion of the cost for three months (75% the first month, 50% the second and 25% the third). Even occasional transit riders can qualify provided you've never claimed the incentive before—but the more frequently you ride, the more you save.
- 3. Carpool when you can.** Your schedule may match up with another hybrid worker who'd like to share the ride to save on gas. Or there may

Do You Drive an EV?

California's program that allows certain hybrid and electric vehicles to use carpool lanes—even with a single occupant—is set to expire Sept. 30. Carpools of two or more people can use carpool lanes at no cost at all times.

Ride RTA for 25 Cents—Plus Youth Ride Free

Now through Aug. 31, you can ride Riverside Transit Agency (RTA) buses for only 25 cents. The discount rate applies on all fixed-route buses and GoMicro shuttles every day, including weekends.

Also, youth 18 and under can ride RTA buses for free.



be a full-time commuter who'd like to carpool a couple days a week. You'll not only save on gas, but you may even be able to use time-saving carpool lanes (which are free for two-person carpools in Orange County).



4. Buy a more flexible Metrolink pass. If you commute fewer than three times a week, the monthly pass isn't the bargain it is for daily commuters. The train can still be a deal, however. Metrolink now offers a \$15 day pass for unlimited rides all day on weekdays. It's not only faster than sitting in traffic, but the new daily discount fare can make it especially affordable if you have a long commute. A 5-Day Flex Pass also saves over the cost of paying per ride.

5. Sign up to pay transit costs using payroll deduction. No matter how often you ride, if you **purchase fares through the rideshare office using payroll deduction**, you'll pay using pre-tax dollars. That lowers your overall taxable income, saving you money.



Metrolink New Fares, Changes in Passes Now in Effect

Metrolink introduced a new fare structure on July 1. Among the changes:

- Monthly Pass Fare Reduction:** The price of a monthly pass dropped by an average of 10%. It continues to be the most cost-effective option for people who ride the train at least three times a week.

- New Passes:** Metrolink now features a SoCal Day Pass that offers unlimited rides for \$10 on weekends and \$15 on weekdays. An LA Zone Pass will be \$5 for rides all day between select stations near downtown Los Angeles.

• Streamlining Pass Options:

The round-trip, 10-Day Flex and 7-Day pass options have been discontinued. The 5-Day Flex Pass is still available. In addition, the Student Adventure Pass program has ended and is replaced with a 50% discount. Other everyday discounts haven't changed, and veterans now qualify for a 10% discount.

San Clemente Rail Service Now Open



Good news: Passenger rail service through San Clemente reopened in June.

It had been suspended since April to allow crews to reinforce sections of track at immediate risk from landslides and coastal erosion.

The section repaired is the only coastal rail link between San Diego and Orange counties. Over the past four years, San Clemente's eroding bluffs have repeatedly forced the closure of the rail line that had otherwise operated largely uninterrupted for more than 125 years.



Before You Hop in a Carpool or Express Toll Lane, Here's What You Need to Know...

If you carpool to work—or are thinking about starting—you may be able to shave time off the drive by using carpool lanes or express toll lanes. Here are eight important things you need to know to take advantage of Southern California's vast network of these lanes:

1. You can cruise past traffic in express toll lanes even if you're on a budget. Carpools with three or more people can ride free or at a discount in Orange County's express toll lanes on the 91 and 405 freeways. You must have a FasTrak account and a transponder—even if using the lanes for free.
 - On the **91 Express Lanes**, carpools are required to drive through the HOV3+ Carpool Lane at each toll point to receive the carpool discount.
 - On the **405 Express Lanes**, carpools must have a working transponder set to the number of people in the vehicle.
2. All regular carpool lanes in Orange County are free and open to carpools with a minimum of two occupants. No transponder is required.



3. Yes, kids count as carpool passengers.

Back to School – Free and Discount Rides for Students

Students can ride free or at a discount on many transit providers throughout Southern California. Here's how:

Orange County

Youth ages 6-18 can ride free on OC Bus with a **Youth Ride Free pass**. The pass is available directly from participating schools or you can request one from Orange County Transportation Authority at octa.net.

Metrolink

As part of a recent fare restructuring, Metrolink no longer offers free rides for students. However, students get a 50% discount—including K-12, trade school, college students and student interns—to travel anywhere on the Metrolink system.

Los Angeles County

With an active **Metro GoPass TAP card**, students at participating K-12 schools and community colleges can ride free on Metro Bus and Rail as well as more than a dozen L.A. County transit providers.

- Orange County changed from double yellow lines to double white lines to indicate where you cannot cross into a carpool lane. If you see a single solid white line, you can enter/exit the carpool lane, but only if it's safe to do so. Stretches of carpool lane with dashed white lines are the preferred entry/exit points.
- You don't have to worry about getting stuck at work in an emergency or work unexpected overtime on a day you carpooled to work. You can be reimbursed for the cost of a taxi, Uber/Lyft or transit ride (up to two times a fiscal year) through the County's **Guaranteed Ride Home program**.
- California's program that allows certain hybrid and electric vehicles to use carpool lanes— even with a single occupant—is set to expire Sept. 30. That means you may no longer be able to drive solo in the carpool lane in an EV. Although Gov. Gavin Newsom signed legislation that extends the program to Jan. 1, 2027, the federal government will need to allow states to extend their programs for that extension to take effect.
- Fines for driving without the proper number of occupants vary.
 - On the 91 Express Lanes, as of Aug. 1, occupancy in the 3+ carpool lane will be verified. If fewer than three occupants are detected, the toll and a \$5 fee will be charged.
 - On the 405 Express Lanes, each violation is assessed a \$25 initial penalty in addition to the amount of the toll.
 - Getting caught driving in the carpool lane without enough occupants (unless with a valid EV sticker) is a minimum \$490 fine.
- The Rideshare Office can help you find a carpool partner—someone who works and lives near you and has a similar schedule. You can also get a list of potential carpool partners at ridematch.info or by calling 511.



Important EV Updates

Carpool Lane Access Ends With 60-Day Grace Period

Electric vehicle drivers as of Sept. 30 no longer have access to carpool lanes if driving alone, per a new federal law. However, California is allowing a 60-day grace period as of Oct. 1—meaning if you’re caught driving solo in carpool lanes during that time with an EV decal, you won’t be cited.



Thinking of Buying or Leasing an EV?

Even if the carpool lane incentive has ended, driving an EV offers plenty of other advantages—including saving thousands of dollars each year in fuel costs.

Find out more about EVs during **National Drive Electric Month**, which continues through Oct. 12.

It features dozens of EV events—from virtual workshops to EV showcases and even a chance to test drive vehicles.

The County also offers a **one-time \$100 bonus** when you lease or buy a qualifying EV.

Are You No Longer Able to Use the Carpool Lane?

Electric vehicle drivers can no longer legally drive alone in carpool lanes, per federal law. The change went into effect Oct. 1. If you are caught driving solo in these lanes—even with a decal—you can be cited.

That's the bad news. The good news: All carpool lanes in Orange County require only two occupants per vehicle. If you'd like to keep using these time-saving lanes, the Rideshare Office can help you find a carpool partner—someone who lives and works near you and has a similar schedule. You can also get an instant list of potential carpool partners at ridematch.info or by calling 511.

6 Surprising Ways Vanpooling Could Be a Better Way to Get to Work

A vanpool is group of people who commute together regularly in a leased van, splitting expenses. It's ideal for commutes of 15 or more miles each way. Here, we highlight a few facts so you can see if you might benefit from making the leap into vanpooling!



1. It's one of the least stressful commuting options. Typically, one or two people sign on to handle driving duties (often in exchange for a reduced fare). The rest get to relax on the ride however they like. "A vanpool can be a quiet and comfortable ride where people drink their coffee, listen to music or podcasts, scroll their phones, have a chat with a fellow rider—or simply enjoy a few calm minutes before work," says Candace Garcia,

rideshare program consultant.

Each vanpool typically sets its own rules and policies to make it as good a fit for everyone as possible.

Important news for County and Superior Court employees who ride transit: Your 2026 Perk Pass will be mailed to your home address during the first two weeks of December.




If you've moved in the last year, contact the Rideshare Office immediately to ensure you receive your pass.

The new annual Perk Pass is valid from Jan. 1 - Dec. 31, 2026.

IRS Cap Up \$15

For the 2026 tax year, the IRS has increased the pre-tax limit for transit and vanpool fares from \$325 to \$340 per month.

If you vanpool or ride transit and you aren't paying for fares using payroll deduction, you could be missing out on tax savings. To find out how to sign up, contact the Rideshare Office at rideshare@ceo.oc.gov or 714.834.7600.

2.

You may be able to vanpool even if you work a hybrid schedule.

Yes, vanpools are best for employees who work regular hours, but that doesn't have to mean regular hours *every day*. Because riders are splitting costs—**plus there are available subsidies of up to \$800 a month toward lease costs**—vanpooling may still be an affordable option even if you're commuting into the office as few as three days a week.

3.

Vanpools don't require a lot of riders to qualify for subsidies.

Orange County Transportation Authority's vanpool subsidy is available to leased vanpools that seat seven to 14 passengers. The program only requires 50% occupancy to get started.



4.

Vanpools can breeze past traffic in carpool and express lanes—free or at a discount.

If you have at least two people in the van you can ride in any of Orange County's time-saving carpool lanes.

You'll also get a bargain on tolls on express lanes (a valid transponder and account is required).

- 91 Express Lanes: 3+ person carpools/vanpools ride free except eastbound weekdays from 4 to 6 p.m., when they get a 50% discount.

- 405 Express Lanes: 2-person carpools/vanpools ride free during non-peak hours, and 3+ person carpools ride free at all times.

5.

You'll not only save on gas costs and wear and tear to your vehicle, but you could also save on income taxes. Vanpoolers can sign up to pay for fares through the Rideshare Office using pre-tax dollars, lowering your overall taxable income.

6.

You may be able to find a seat on an existing vanpool—or set up a new vanpool.

To find if there's an open seat on a vanpool, log into ridematch.info. Enter information about your commute such as where you live and work and your schedule. You'll get an instant list of any vanpools on your route.



If there's no vanpool serving your commute, it's easier than you may think to get one off the ground. Contact the Rideshare Office for help. They can identify coworkers with a similar commute. They'll even set up a "meet and greet" of your potential vanpool riders.
